

SCAA MEMBER INVITATIONAL POLICY

2 – 3 Member Invitational shows are scheduled each year. Each show features the work of 8-10 SCAA Artist Members. Artist Members are current members of the SCAA whose work has been accepted into a **juried** show at the SCAA. Each show is comprised of a group of artists whose work represents a variety of media, 2D and 3D. Artist selection is based on show participation, quality and consistency of work. Opportunities to participate in a Member Invitational show for any individual artist may occur at least but not more than every three years. Artwork

Each artist participating is able to exhibit about eight pieces of work. This is a ballpark figure, more pieces may be shown if your pieces are small, or less if they are very large. There are no size restrictions. 2D work must be wired and ready for hanging. Framed work should enable a harmonious grouping of your work

As a general rule it is better to show work that has not been exhibited before, at least at SCAA. That being said, the invitational shows can include anything you wish, whether it's been shown or not. I allow this because sometimes a piece that's been shown individually may complete or be part of a series or body of work which an artist may be choosing to show in its entirety.

Fees / Requirements

Each participating artist is required to contribute \$75 to help cover the costs of the exhibit.

Each participating artists is required to bring a food item or wine for the Opening Reception.

Each participating artist should submit an Artist Statement and/or resume which visitors may view while their work is on display. Artists are also welcome to bring business cards or other information you may wish to have available during the show.

Each participating artist must submit an image of their work to be used for the invitation postcard and promotional purposes. Resolution must be 300 dpi or greater.

Sales

“Sets” of pottery or sculpture must be priced as a set, not individually. No more than 1/4 of your exhibited work should be marked “not for sale”. SCAA will retain a 30% commission on all sales.

Liability

Although all possible care is taken, SCAA cannot be responsible for any loss or damage to your artwork, it is recommended that artists carry their own insurance.

SCAA JURIED EXHIBIT POLICY

Artwork

Each artist may submit up to 3 original works. Works must have been finished in the last 2 years and not shown previously in an SCAA juried exhibit*.

2D work may not exceed 48" in any dimension, and must be wired and ready for hanging.

3D work must be easily transportable.

*Work may not be submitted that has previously been accepted in another juried show. Work that was submitted but not accepted for a juried show may be submitted again to another juried show. Work that has only been displayed in a non-juried show or event (Invitational / Art Heist / Holiday Sale) may be submitted for a juried exhibit.

Entry Fees

Members: \$20 for single entry, \$15 each for multiple entries

Non-Members: \$25 for single entry, \$20 each for multiple entries.

Student / Military Veteran: \$12 per entry (with valid ID).

Entry Fees are non-refundable.

Sales

"Sets" of pottery or sculpture must be priced as a set, not individually. No more than 1/4 of your exhibited work should be marked "not for sale". SCAA retains 30% on sales of work by members, 35% on sales of work by non-members.

Liability

Although all possible care is taken, SCAA cannot be responsible for any loss or damage to your artwork, it is recommended that artists carry their own insurance.
